1:5 year event on Department of Water land started late in the day

- Hadleton Reserve fire 15 March 2016
 - 60Ha fire was detected when 20Ha burnt
 - Started as a pole top fire
 - -Managed out of Collie DPAW office
 - -Two fixed wing and two heli aircraft and up to 40 brigade members attended
 - Volunteers initially reluctant to back burn

-As a result of Waroona fire reports there may be changes including the establishment of Incident Management Teams set up prior to events

-General opinion was that all agencies worked well together

-DPAW Operations Officers have authority to decide on course of action without waiting for approval from head office or the like.
