5. Reports

5.1 Chief Bush Fire Control Officer

The Chief Bush Fire Control Officer, Duncan South, reported that it had been a very quiet season.

- Towards the end of the season there have been a few fires on our boundary with the shires of Collie and Boyup Brook, some deliberate.
- A new truck has been allocated for Arthur River.
- Appreciation to Brad for support as Deputy Chief
- Appreciation to Shire Office staff for their support since the loss of the CESM.
- Trial of once per week radio call ups this year. Did not improve responses. Some brigade officers still not doing radio checks.

5.2 Parks and Wildlife, DBCA

Tim Hutton, reported that

- aviation support had been extended to 20 April
- Parks and Wildlife have not started autumn burning as soil dryness is still a concern – looking for a bit more rain.
- Deliberate fires are not new, though seeing a change in location i.e. on the eastern boundary.

Including Parks and Wildlife in Whatsapp was discussed, for notification purposes for fire permits and Duncan indicated that he would have further discussions with Parks and Wildlife personnel.

5.2 Arthur River Bush Fire Brigade

Very quiet, couple of fires just inside the Wagin Shire.

5.3 Darkan Bush Fire Brigade

Very quiet season.

5.4 Duranillin Bush Fire Brigade

Fires on western end of the Shire. Not many agriculture fires.

5.5 DFES - District Officer

Simon Vogel reported that DFES is waiting on the announcement of the new Rural Fires Services structure.

Simon trained 9 people in the Fire Control Officer course in Darkan recently.

5.6 DFES – Bush Fire Risk Management Officer

Donna Morgan reported on the Bush Fire Risk Management Plan and in particular the treatment plan.

- West Arthur has been successful in gaining \$45,000 for mitigation works. Mitigation Activity Fund has strict criteria – town sites and crown land.
- Most works are on ground mechanical works. Fire access tracks and three burns in Bowelling. Works to be completed by 30 June. Local brigade members can attend burns which are being carried out by contractors.
- The programme that Donna and Peter are involved with is due to finish at 30 June. Will know when Rural Service announcements are made whether there will be an ongoing programme.

FPC indicated that they would like to be involved with the burns.

There was some discussion regarding the potential for Arthur River and Moodiarrup sports grounds to be included in future mitigation works.

5.7 Forrest Products Commission

- Honey property has now been planted.
- Political pressure to plant for pines on ex blue gums sites.
- Still very active in this Shire and going through a growth phase.
- New lease for grazing the Moodiarrup property will be advertised in the near future.
- Strategic asset protection branch will be putting together fire management plans for plantations. Will start to build their own response structure.

5.8 Department of Water

- Two fires in plantations in the Shire of West Arthur this year. DoW used Working with Fire to assist this year with mopping up etc.
- Department of Water is undertaking fire management planning. First management plan – concentrating on plantation and protection of farming.
- Hoping to do prescription burn near Cordering and mechanical works.

7. General Business

7.1 ESL Allocations

2017-18 Arthur River Brigade – 4.4 Broadacre Single Cab - \$412,000 approved waiting for delivery.

2018-19 - Operating grant of \$31,670 offered. There are no inclusions in the capital 2018/19 replacement program.

No additional request for a light tanker was submitted as the information provided by DFES stated, "New and additional appliance/vehicle requests will again not be considered for approval" This is due to the number of current reviews/projects such as light fleet review, crew cab protection initiatives and future fleet project.

7.2 Training

Fire Control Officer's Course held 23 March 2018.

Western Power training was discuss and the Shire will investigate whether we can have a Western Power Training Session in the Shire similar to what was available in the region last year.

7.3 Call up

Call Up changed to once per week this year.

Discussed that when Monday is public holiday perhaps call up Tuesday instead or change all call ups to Tuesday. Will continue with once per week.

7.7 Mid Band and High band

Removing the link between mid and high band was discussed. This would mean that Shire radios would not be heard on the bush fire network.
