### STERILISATION

To licence a dog under sterilised concessional rates, an owner or agent should either have a veterinarian's certificate or be prepared to sign a statutory declaration to that effect.

### WORKING DOG

The definition of a Working Dog for concessional licencing purposes is a dog used for "droving or caring of stock.

### PENSIONERS

The definition of a Pensioner for concessional licencing purposes is as follows:

- a) A person issued with a Pensioner Concession Card or State Concession Card; or
- b) A person issued with a Seniors Card AND a Commonwealth Seniors Health Card

A copy of your card must be presented at the time of registering to receive a concessional rate.

**NUMBER OF DOGS**

The maximum number of dogs to be kept on any premises is two (2) over the age of three (3) months. Approval can be sought to keep more than two (2) dogs in some cases, but this is subject to certain other conditions being met. **DANGEROUS DOG/RESTRICTED BREED**

The keeping of a dog classified as a “dangerous dog” is not prohibited, however special requirements do apply. Failure to declare the breed of your dog, if it is one of the dangerous/restricted breeds is an offence.

**CANCELLATION OF A REGISTRATION**

A Dog Registration can be cancelled if:

- The owner is fined or convicted for 2 or more offences in any one year
- The dog has shown to be destructive, dangerous, vicious, unduly mischievous, or to be suffering from an infectious disease
- The Council is not satisfied that fencing requirements of the place at which the dog is ordinarily kept are satisfactory.

**CONTROL OF A DOG IN A PUBLIC PLACE**

A dog shall not be in a public place unless:

- It is held by a person who is capable of controlling the dog;
- It is securely tethered for the purpose of control by means of a chain, leash, or harness of sufficient length no longer than 2 metres.

**IMPOUNDMENT**

If a dog is seized and impounded, the owner has seventy two (72) hours to collect the dog before it is disposed. Impoundment fees will apply, and MUST BE PAID before the dog is released, plus an additional fee per day for every day the dog is kept in the Pound.

**DECLARATION BY OWNER/AGENT**

1. I, the registered owner, am 18 years of age or over;
2. I certify that for the purpose of section 16 (1ba) (c) of the Dog Act 1976 that the dog will be effectively confined in/or at the premises;
3. I am not currently banned, or have been banned from owning a dog under the Act either permanently or for a period specified.
4. I declare that the information I have provided is true and correct. I am aware it is an offence to provide false or misleading information.
