#### OWNERSHIP

Owner of the cat must not be under the age of 18. Cat must be microchipped. Cats must be sterilised, unless approval has been obtained from the Shire of West Arthur for you to act as a registered breeder.

#### PENSIONERS

The definition of a Pensioner for concessional licencing purposes is as follows:

- A person issued with a Pensioner Concession Card or State Concession Card; or
- A person issued with a Seniors Card AND a Commonwealth Seniors Health Card

A copy of your card must be presented at the time of registering to receive a concessional rate.

#### NUMBER OF CATS

The maximum number of cats to be kept on any premises is two (2) over the age of three (6) months. Approval can be sought to keep more than two (2) cats in some cases, but this is subject to certain other conditions being met. Please contact the Shire of West Arthur on 9736 2400 for further information. The Cat Act 2011 requires registration tags to be worn at all times.

#### NUISANCE

Wandering cats can prove to be a nuisance for neighbours, particularly non-cat owners. If Council Rangers deems your cat to be a nuisance, you may be required to confine your cat within your premises.

#### CANCELLATION OF A REGISTRATION

A Cat Registration can be cancelled if:

- The owner is fined or convicted for 2 or more offences in any one year
- The cat has shown to be destructive, dangerous, vicious, unduly mischievous, or to be suffering from an infectious disease

## **IMPOUNDMENT**

If a cat is seized and impounded, the owner has seventy two (72) hours to collect the cat before it is disposed. Impoundment fees will apply, and **MUST BE PAID** before the cat is released, plus an additional fee per day for every day the cat is kept in the Pound.
